- Copy of college transcripts Completed Applicant's Statement SSA-1945 Form
- Completed Employment Eligibility Form (I-9) - original ID(s) are required to be presented, examined and photocopied at the ESC
- Copy of BCI & FBI Reports (within 1 year) - If you do not have, call our office to schedule an appointment for WebCheck fingerprinting
- Substitute Teacher Training Certificate (One-Day Seminar or Online Training) - exempt from this requirement if degree is in education
