The Preservice Department is anxious to return to the classroom. Each region is committed to ensure the safety of our employees and our bus professionals. Class size will be determined by state guidelines. The limited class size will be offered first to those drivers that have expired certificates or their certificates are close to expiration. Classes will be offered more frequently at the Pickaway County Central Region ESC, Licking Heights Transportation and Columbus City Moler Transportation during the summer. In accordance to Governor Mike DeWine's office and the Ohio Department of Health, the Preservice Department will be implementing the following requirements for all future classes:

- Maintain a six (6) foot distance from colleagues at all times; this includes entering and exiting the building.
- Practice good hygiene and wash your hands frequently. Hand sanitizer is available in high contact areas when washing is not an immediate option.
- Refrain from shaking hands and sharing materials.
- Attendees should remain seated in the same chair during the preservice class.
- Those attending the preservice class must be spaced at least 6-feet apart regardless of the capacity limit.
- Face coverings are required.
- Temperature checks and a health screening will be required for all attendees.
- Desks, chairs, and all materials will be sanitized between each session.

Safety is at the forefront to all transportation guidelines, including the classroom. As we move forward to the upcoming school year, our office is asking for your patience and understanding. More information will be forthcoming regarding times and dates of preservice classes. Please contact our office if you have any questions.

**Health Screening Questions for Use With Customers
(Administered verbally by employee)**

We are sorry, but customers who answer “yes” to either of these questions cannot receive services until:

- At least 3 days (72 hours) have passed since recovery, defined as resolution of a fever (100.4 degrees or higher) without the use of fever-reducing medications AND improvement in respiratory symptoms (e.g., cough, shortness of breath).
- AND at least 10 days have passed since symptoms first appeared.
